The New Hampshire School Administrators Association, in coordination with the American Association of School Administrators, has announced that Dr. Lorraine Tacconi-Moore is the New Hampshire Superintendent of the Year for 2019. Dr. Tacconi-Moore, Superintendent of Schools for the Henniker, Weare, John Stark Regional and Stoddard School Districts (SAU #24) will receive a special award during the AASA National Conference on Education in Los Angeles, CA, in February 2019.

Lorraine was selected for this honor by a panel of her peers and from a distinguished group of nominees. Marjorie Burke, Chair of both the Weare and SAU 24 School Boards, and Jacqueline Coe, Assistant Superintendent of SAU 24, noted that Lorraine often takes limited resources and creative thinking in order to optimize the SAU and Districts' budgets to improve all five schools that the SAU serves. Marjorie Burke said "Lorraine has a strong focus on doing what is best for kids; their needs are first and foremost in all her efforts to provide optimum opportunities for learning."

Lorraine's educational background includes a Bachelors of Arts from Smith College; a Masters of Art Education from Rhode Island School of Design; and a Doctorate of Education from University of Massachusetts- Lowell. Lorraine started her administrative career as Director of Fine Arts for the Groton-Dunstable Regional School District, and then became Assistant Principal for Groton-Dunstable Regional High School. She then became Principal at Littleton Junior-Senior High School before becoming Assistant Superintendent of Schools in Westford, Massachusetts. Lorraine became Superintendent of Schools in SAU 24 in 2010, where she remains today.

Lorraine currently serves as an executive board member and president-elect of the New Hampshire School Administrators Association; is a past chairperson and current member of the Southwest Superintendent Regional Committee; is a member of both the American Association of School Administrators (AASA) and Association for Supervision and Curriculum Development (ASCD). Lorraine is also a past member of the Massachusetts Art Education Association. She has also participated in many local committees, has received many honors and awards, and was most recently selected by Homeland Security and Emergency Management to be part of their interview panel, representing K-12 education.

Lorraine attributes her success to her family: her husband, Dennis, who has championed her throughout her career, her two children, Gina and Greg, her four Italian immigrant grandparents, and her parents. Lorraine believes that the many years she spent as a classroom teacher has made her a better superintendent, and values the positive working relationship she has with her four school boards. In her free-time, Lorraine enjoys designing jewelry, cooking for family and friends, antiques, and spending time by the ocean.

Dr. Carl Ladd, executive director of the New Hampshire School Administrators Association, stated, "Lorraine is an outstanding representative of the many school superintendents in our state who work everyday in support of public education. Granite State Leadership Academy

For the third year, NHSAA is spearheading, in partnership with the NH Department of Education, the **Granite State Leadership Academy** for aspiring principals and superintendents. As we know, creating a pipeline of highly qualified, motivated, and thoughtful leaders to lead our schools and systems into the 21st Century has been of major concern for many years. The Leadership Academy is our effort to provide a response to that concern.

We introduced the academy as a proposal to our members in Fall 2015, with the application process beginning in Spring 2016. The overwhelming response from members and applicants was extremely positive, with 29 applicants applying for 20 available slots in the inaugural cohort, with interest still demonstrated through our many applications received year after year.

Participants and their sponsoring districts have agreed to commit to a rigorous 3-year long professional development schedule that highlights the seven areas of systems leadership: *General Leadership, Personnel, Finance, Curriculum & Instruction, Student Services, Capital Maintenance & Improvement, and Communications & Community Relations*. This includes participation in all NHSAA sponsored professional learning activities, several 1 and 2-day seminars, and agreeing to a year-long coaching/mentoring relationship as they assume new leadership positions within our state.

This is an exciting leadership and learning opportunity for aspiring leaders from around the state who are committed to personal and professional growth and believe that New Hampshire children and public schools deserve leaders who have and can communicate a powerful vision, aim for and achieve extraordinary results, demonstrate exceptional skill, possess steadfast will, and will champion the needs of *all* children.

77th Annual Conference on Educational Leadership & NHSAA Business Meeting



This past June, NHSAA moved our Annual Conference from the Mountain View Grand Resort to the Omni Mount Washington Resort, due to growing member numbers. NHSAA received positive feedback from the Conference this year and we are looking forward to upcoming Annual Conferences at the Omni!

Throughout the conference, our members had the opportunity to hear presentations from George Couros, Cassie Yackley, Dan Domenech, Carol Kilmister, Mike Ricker, Kate Spillane, Curt Steinorst, Leslie Finnan, and Jim Morse, who was New Hampshire's 2018 Superintendent of the Year.

On Monday, members arrived and speaker George Couros spoke about his book, *The Innovator's Mindset*. He discussed the idea and characteristics of "The Innovator's Mindset" and shared examples of why that mindset is important for educators. George has worked with all levels of school – as a teacher, technology facilitator, and both school and district administration.

After a short break, members had the opportunity to hear General Counsel Mike Ricker, Human Resources Consultant Carol Kilmister, and Attorney Kate Spillane from Primex³ as they used scenario-based learning and group discussion to review good employment practices. This was a unique opportunity to review a series of situations that create the highest exposure to employment liability, while still focusing on the value of strong foundational practice.

After lunch, in a presentation entitled, "Addressing Violence in Public Education: The Vital Role of Administrators in Creating Trauma Competent Schools," psychologist Cassie Yackley spoke about creating "trauma competent" schools to ensure safety and promote learning for all students. This was aimed to inspire school administrators to implement next steps in their own schools.

On Tuesday, distinguished lecturer and New Hampshire's 2018 Superintendent of the Year, Dr. James Morse, spoke to the group. AASA Executive Director Dan Domenech also shared the latest news on the federal appropriation increase for public education, and other federal decisions that will affect schools. It was a pleasure to have the national perspective at our conference.

Curt Steinhorst, Founder and CEO of Focus|Wise, shared a presentation based on his book, *Can I Have Your Attention? Focus Your Team and Revive Engagement in the Districted Classroom*. The focus was on how technology has altered the way people engage, communicate, and relate to one another and the challenges that brings.

Tuesday evening was a reception recognizing Retirees, outgoing Executive Board members, NHSAA president Terri Forsten, honoring deceased members, recognizing our sponsors, and much more. One of the evening's highlights was a lively auction with items that included mostly outdoor activities such as sporting event tickets, zip-lining adventures, skiing, and many other fun contributions from all five regions.

Wednesday concluded our 77th Annual Conference with the NHSAA Business Meeting, golf awards, a discussion about federal legislation led by Leslie Finnan of AASA, and a general DOE update and discussion led by Commissioner Frank Edelblut, Deputy Commissioner Christine Brennan, Division of Educational Improvement Director Heather Gage, and Division of Program Support Director Caitlin Davis.

Special Education Support Center News

The Changing World of the Special Education Administrator

NHSAA's Special Education Support Center (SESC) recently surveyed its members on the roles and responsibilities each person holds within their district. More than half of the SESC members responded and the results were not surprising based on the questions raised by our SESC members over the past two years. With the exception of one district, according to the survey, each district or SAU has an administrator to oversee special education. However, in New Hampshire, the roles and responsibilities of the director usually go beyond special education services and programs. Indeed, less than 10% of our members' duties are solely special education oriented.

Special education administrator titles have changed to align with the scope of the position. Those with additional duties hold the title of Student Services or Special Services Directors or a similar title. Of the survey participants, more than 80% are responsible for overseeing Section 504 and almost 90% serve as juvenile court liaisons with 71% of those surveyed overseeing English Language Learners' programs. Directors may be Homeless Liaisons as required under the federal McKinney-Vento Law (60%) or they may supervise school nursing services (42%), coordinate homebound services for non-special education students (42%), or oversee school counselors and programs (21%). A few directors are responsible for Title I, Title IX, homeschool students, administrators of alternative programs, or other administrative duties as assigned.

As a direct result of the aforementioned changes, the Special Education Support Center's services have expanded over the past few years. As our New Hampshire student and staff needs have changed, so have the resources provided by NHSAA's SESC to meet the same.

We welcome our new special education administrators or others as appointed by their superintendent to join NHSAA's Special Education Support Center. Enrollment is on a sliding scale based on student enrollment. In addition, if your district is a member of the Primex³ Property and Liability program, members are entitled to a 50% discount of the SESC fee. 2019 Champions for Children Awards

For distinguished public service to benefit children in New Hampshire

1. **BACKGROUND ON THE NHSAA CHAMPIONS FOR CHILDREN AWARDS:**

The New Hampshire School Administrators Association (NHSAA), a non-profit corporation dedicated to improving the quality of education for public school children, has established a CHAMPIONS FOR CHILDREN award program to recognize New Hampshire citizens who have given distinguished public service to benefit children. The NHSAA organization includes New Hampshire Superintendents of Schools, Assistant Superintendents, School Business Officials, Special Education Directors, and other school system administrators.

2. **CRITERIA FOR NOMINATION:**

- A. Each nominee for the NHSAA CHAMPIONS FOR CHILDREN award must embody, through action, the beliefs in the NHSAA CHAMPIONS FOR CHILDREN policy (listed below).
- B. The nominee must live or work in New Hampshire
- C. The nominee must be initially selected by NHSAA members in an SAU
- D. NHSAA members or their families are not eligible for the award
- E. School board members and school staff are eligible for this award for extraordinary service to children that is above and beyond their normal responsibilities. Nominees who are Board members or employees are more than excellent in their roles. Their nomination shall reflect unique and special service that, on a voluntary basis, champions the cause for children. School Board members and school staff are not eligible for this award as a result of their normal service.

3. **NOMINATION FORM:**

You may nominate more than one person, but we ask that you use a separate form for each nominee. Please summarize your nominee's activities in one hundred (100) words or less on that form. Support materials (letters, newspaper articles, your own thoughts, etc.) may be attached. Each nomination must be accompanied by three letters of reference. Please note that we do not accept faxed nominations.

4. **SELECTION PROCESS:**

- A. **BY FEBRUARY 4, 2019** each SAU's NHSAA members may select a nominee. The nomination form and attachments must be sent to the NHSAA Regional Chairperson. The SAU administrators will determine how to honor the SAU CHAMPION. NHSAA will provide a certificate to each SAU champion.
- B. **BY MARCH 18, 2019** each Regional Chairperson will select the REGIONAL CHAMPION. We suggest each chairperson appoint two other members of the region, from different SAUs, to work with him/her to select the REGIONAL CHAMPION FOR CHILDREN. We suggest each region invite their CHAMPION to a breakfast or luncheon.
- C. **BY APRIL 5, 2019** the Committee of Judges, having received the letters about the five regional champions, will select the STATE CHAMPION FOR CHILDREN who will be honored by NHSAA at a state-wide event scheduled for **MAY 10, 2019**. All regional winners will receive a plaque at that event.
